

## NOTICE

### Master Course in Animal Production and Tenology

#### Academic year 2017/2018

1. The notice regulates the opening of the application process for the school year 2017/2018, for 2nd cycle for obtaining the master degree in Animal Production and Tecnology, published in Despacho n.º 2372/2013, of 11/02, lectured by Escola Superior Agrária de Santarém.

2. Conditions of admission:

May apply for admission to the 2nd cycle of studies leading to the master's degree:

- a) Holders of 1st cycle degree in Engineering in the fields of Agronomy, Animal Production or in related fields, conferred by Polytechnic or University higher education institutions;
- b) Holders of pre-Bologna degrees in Engineering, or its legal equivalent, in the fields of Agronomy, Animal Production or in related fields, conferred by Polytechnic or University higher education institutions;
- c) Holders of other 1st cycle degree in the fields of Agronomy, Animal Production or in related fields, conferred by Polytechnic or University higher education institutions;
- d) Holders of a foreign higher education degree conferred following a 1st cycle of studies organized in accordance with the Bologna Process or that is recognized as meeting the objectives of a 1st cycle degree by the Technical-Scientific Council of Escola Superior Agrária de Santarém, in the fields of Agricultural Sciences or related fields .
- e) Holders of an academic, scientific or professional curriculum that is recognized as attesting the capacity to carry out this cycle of studies by the Technical-Scientific Council of Escola Superior Agrária de Santarém.

The recognition referred in points (d) and (e) has as effect only the access to the cycle of studies leading to the degree of master and shall not confer on the holder the equivalence to the degree of "licenciado" or recognition of that degree.

**3.** For the application process is necessary to submit the following documents:

- a) Application form;
- b) Academic certificate with the classification of the curricular units and academic certificate of conclusion of 1st cycle degree;
- c) Document that certifies foreign higher education degree;
- d) Copy of identification documents (identity card/citizen card/passport card);
- e) Three Curriculum vitae copies.

In case of doubt the jury may ask the evidence of other and/or request an interview.
